LOCATION

Aberfoyle is a popular tourist town within the Trossachs National Park. The town lies approximately 20 miles west of Stirling, 26 miles from Glasgow and 55 miles from Edinburgh.

As the 'Gateway to the Trossachs', Aberfoyle attracts a high volume of tourists, particularly in the summer months.

The subject property is located opposite the Tourist Information Centre in the centre of Aberfoyle.

ACCOMMODATION

The subjects comprise a prominent retail unit with extensive frontage onto Main Street. The unit is arranged over ground floor only.

Based on a rate poundage of 46.6p this rateable value will result in an estimated rates liability in financial year 2017/18 of **£7,363**.

The subjects may be eligible for 25% rates relief under the Small Business Bonus Scheme, subject to conditions.

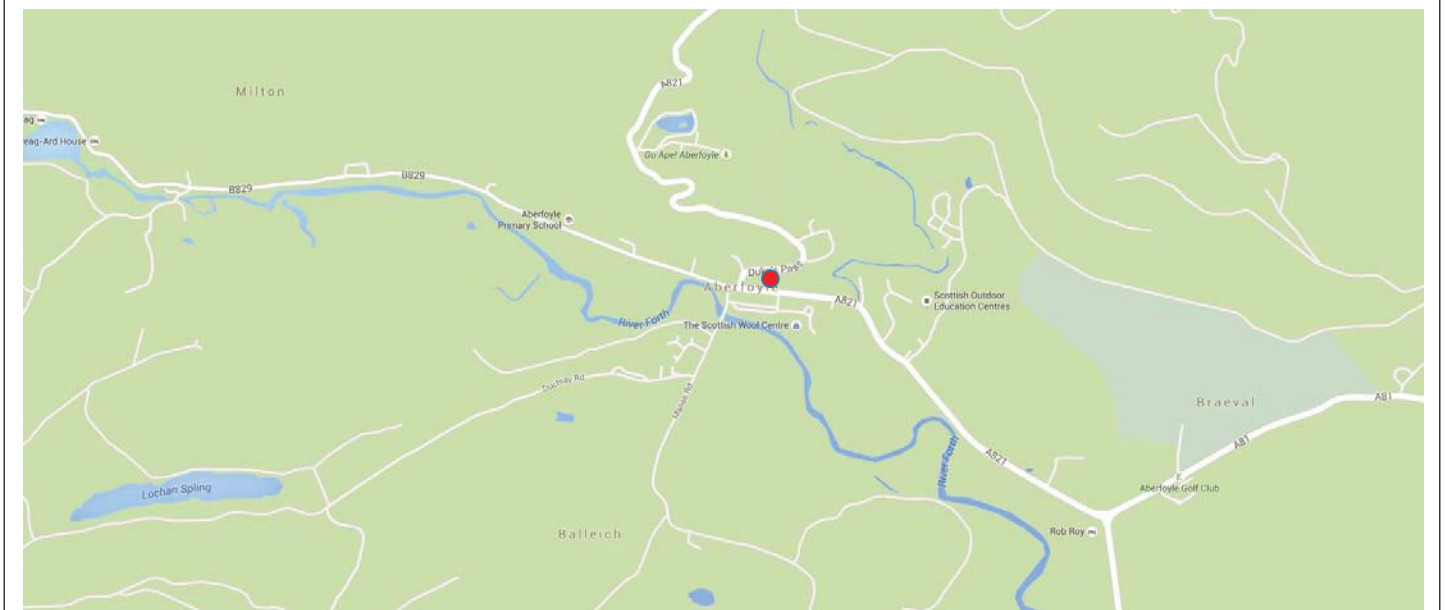
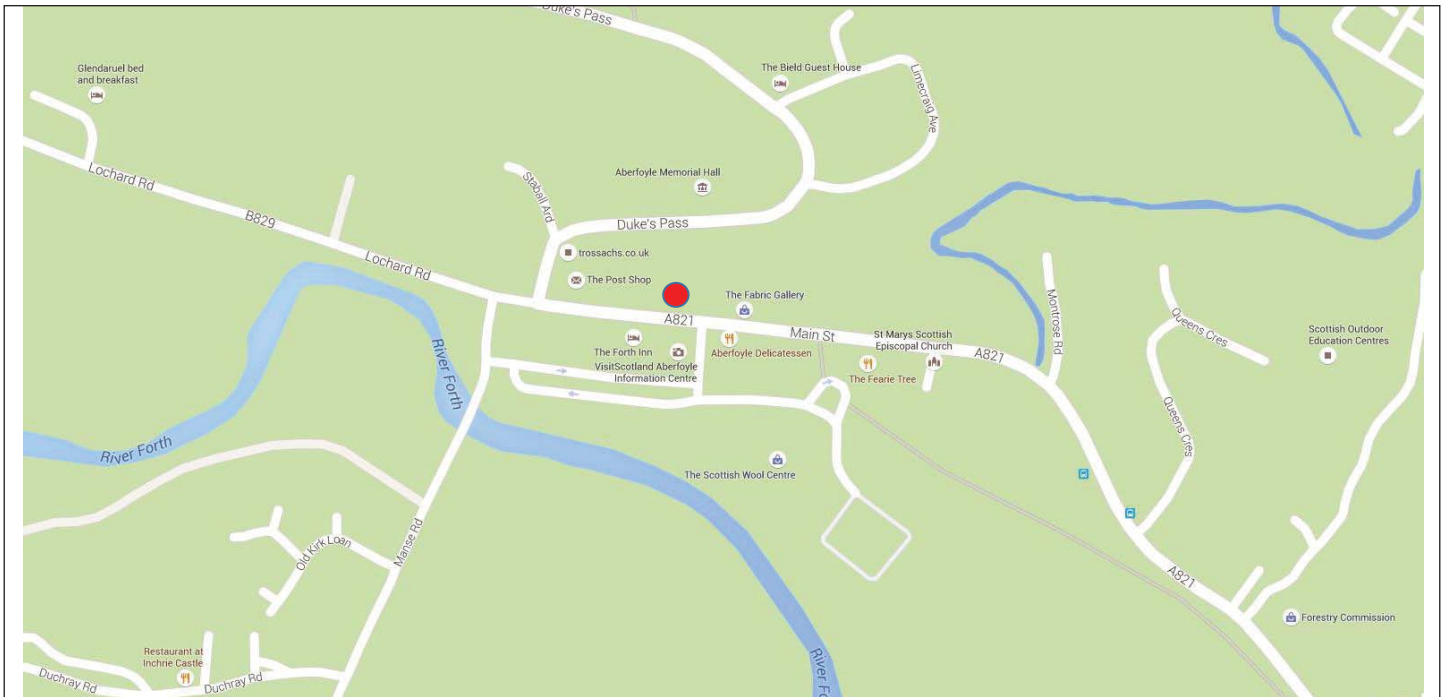
